**Application Requirements**

Candidates who will apply are required to fulfil the conditions specified in the Principles for Admission of Students from Abroad published by the Presidency of the Council of Higher Education.

They must be in their last year of high school or have graduated from high school.

1) Foreign nationals (those studying at secondary education (high school) institutions in Turkey Provided that they have enrolled before the 2022-2023 academic year [except for embassy schools, international private education institutions included in the MOBİS system and foreign nationals brought to our country within the framework of the project carried out by the Ministry of National Education])

2) Those who were Turkish citizens by birth but lost their Turkish citizenship by obtaining a permission to renounce Turkish citizenship from the Ministry of Interior and those who document that they have a blue card issued to those who have lost Turkish citizenship upon request (provided that those who are studying in secondary education (high school) institutions in Turkey have enrolled before the 2022-2023 academic year) (Article 7 of the Turkish Citizenship Law No. 5901. Article 7 of the Turkish Citizenship Law No. 5901 states that ‘(1) a child born within or outside Turkey to a Turkish citizen mother or father within the union of marriage is a Turkish citizen.’ and it is beneficial for candidates who will apply for admission quotas from abroad to examine the Turkish Citizenship Law).

3) Foreign nationals who have acquired Turkish citizenship with the citizenship acquired later / dual nationals in this situation (provided that those studying in secondary education (high school) institutions in Turkey have enrolled before the 2022-2023 academic year)

4) Turkish nationals who have completed their secondary education (high school) in a foreign country other than the TRNC (including those who have completed their secondary education (high school) in Turkish schools opened by the Ministry of National Education in a foreign country other than the TRNC)

5) TRNC nationals who reside in the TRNC and completed their secondary education (high school) in the TRNC and have GCEAL exam results, and those who have or will have GCEAL exam results by enrolling and studying in colleges and high schools in other countries between 2005-2010

Applications are accepted.

### **Recognised Examinations for Application**

The evaluation of the applications is made on the basis of TR-YÖS Turkey Foreign Student Admission Exam and the following exams approved by YÖK. Quotas and base scores and special conditions, if any, recommended by the units are determined by the Senate. New exams and admission principles can be added to the exams mentioned below with the decision of the Senate. The evaluation criteria for the exams accepted in the application are as follows:

a) TR-YÖS Turkey International Student Admission Examination: At least 100 points out of 500,

Conducting the Turkish Foreign Student Admission Examination (TR-YÖS) to be implemented by ÖSYM starting from 2023, conducting the first TR-YÖS in January 2023, conducting the exam in Turkish, German, Arabic, French, English, Russian, conducting the Turkish Foreign Student Admission Examination (TR-YÖS) twice a year starting from 2024, using TR-YÖS results by all higher education institutions in the admission of students from abroad,

b) SAT I (Educational Assessment Test): A total score of at least 1000 and a Maths score of at least 500

c) ACT (American College Test): At least 22 points in Maths, Science and total score

ç) GCE (General Proficiency Exam): A level A in at least 3 subjects, at least one of which is related to the department applied for, and the average of the grades they get in these subjects must be C or above,

d) International Baccalaureate diploma grade of at least 28,

- e) The German ABITUR exam score must be at most 4,
- f) The French Baccalaureate diploma grade must be at least 10,
- g) The Matura diploma degree must be a maximum of 4,
- ğ) Jordan and Palestine Tawjihi exam must be at least 70 out of 100,
- h) Lebanese Baccalaureate grade must be at least 12,
- i) Syria Al-Shahada al-Thanawiyya (Syrian Baccalaureate): At least 150 points in the score type of the applied programme,
- i) Iranian high school diploma (Diploma Debirestan): The average must be at least 12/20 and the Pishtaneshgahi graduation mark must be at least 12/20,
- j) Kazakhstan National University Test: Must be at least 50 out of 100,
- k) Gaokaonda-University of the People's Republic of China Entrance Examination: At least 500 points out of 750 according to the score type of the applied programme,

### **Application Procedure**

- (1) Applications must be made to Ağrı İbrahim Çeçen University Student Affairs Department through our website between the dates given above and Ağrı İbrahim Çeçen University Student Affairs Department.
- (2) Candidates can apply to maximum 3 programs. These programs are specified in the "Application Form for Overseas Student Admission".

### **Documents Required for Application**

- (1) Diploma, Graduation certificate ((Atestat) photocopy
  - (2) Passport (photocopy)
  - (3) TÖMER exam result certificate (if any) showing the Turkish proficiency level of non-Turkish citizens
  - (4) TR-YÖS exam result certificate (Turkey Foreign Student Admission Examination)
  - (5) Internationally recognised examination result certificate
- Note: Original documents will be requested during registration.

### **Documents Required for Registration**

- (1) Original Diploma (Atestat), (Graduation certificate or Atestat must be approved by the Consulate or Apostilled).
- (2) Diploma Equivalency Certificate (obtained from Consulates, Provincial Directorates of National Education).
- (3) Original passport and Turkish translation (notarized).
- (4) Original and Turkish translation of the transcript (Notarized).
- (5) Foreign entry and exit printouts of Turkish nationals
- (6) TÖMER Certificate for non-Turkish citizens
- (7) 6 photographs

- (3) Tax levy fee (4) Copy of passport and Turkish translation
- (5) Proof of address and the last invoice to this address (electricity, natural gas, water, etc.)
- (6) Active student certificate
